

POLICY UPDATE: SEPTEMBER 2022

Regional / National

Transport: The plan of writing to key government members to re-state the case for HS2 and NPR for Leeds and Bradford, and securing signatures from nationally-known businesses, was interrupted by the Prime Minister's surprise announcement that NPR would go ahead. The letter is being re-written to take account of this (with continued pursuance of more signatures).

Skills & Education: Prolonged discussions with other Chambers and the British Chambers of Commerce have continued on the processes of understanding and delivering Local Skills Improvement Plans (LSIPs) for both West and North Yorkshire (the Chamber had two bids approved to deliver these government-backed programmes).

Policy Groups – new members: Following the Annual General Meeting (and the summer election meetings), new members to the three Leadership Groups all had inductions to familiarise them with what is required (all three Leadership Groups met in September).

Bradford

Property Forum: The Steering Group had its first meeting under the new Chair, Matt Rudman of Vectos. Senior Council officer, Julian Jackson, had moved on but the organisation was represented by Interim Assistant Director (AD) Chris Eaton and Angela Blake, AD for Economy.

Cost of Living: The Chamber joined a meeting led by the Council to discuss the cost of living crisis. The focus was not on what more might be done to help either businesses or residents to cope, but to understand the places where help currently exists, and how best to signpost people to it.

Leeds

Leeds 2023: Leeds Leadership Group received a presentation on the plans for the year-long culture festival. (An initial plan to bid for European City of Culture had subsequently been blocked by the EU when Brexit happened in 2016. Council leaders decided to push ahead anyway with its own festival.) Questions and comments included an appeal for activities not to be just focused around the city centre, in order to make all city wards feel involved.

York & North Yorkshire

Digital: Further work and discussions had taken place on the planned roll-out of activities and support for businesses operating in the digital sector. A 'round table', chaired by President Laurence Beardmore, took place on 13 Sep and considered next steps.

York Business Festival – Continued assistance with the planned month-long event had taken place. Suggestions for speakers, and awareness-raising were just some of the ways in which the Chamber was offering support.
