

POLICY UPDATE: FEBRUARY 2023

Regional / National

Environment

The Chamber Transport Group received a presentation on Bradford's Clean Air Zone from that local authority's Director of Air Quality Programme, Andrew Whittles. There had been no effect on traffic levels, while £3.2m had been obtained in revenue. 52,000 penalty notices for contravention had been issued.

Fair Work Charter

The Chamber (along with the FSB and CBI) had provided details of some SME members for the Mayor's office to speak to elaborate on the concerns raised around implementing the Charter. (The Mayor's office had originally requested that several SME focus groups be facilitated by the BROs, but this was deemed impractical and unproductive.)

Bradford

Showcasing the city

A Property Forum event, attended by almost 50, heard how the city plans to have a significant presence at an upcoming three-day property event in Leeds, known as UKREiiF (UK Real Estate Investment & Infrastructure Forum). The Council presented on various schemes underway or in the pipeline, including a £50 million hydrogen production facility.

Planning

The team has been liaising with Bradford Council and its consultants on plans to introduce a Design Code. Property Forum Steering Group members have raised eyebrows on the effects this could cause in its current draft and the Chamber plans to make a formal submission later in the year.



Leeds

Environment

Almost 60 attended a Property Forum held at Pinsent Mason law firm. The subject was Net Zero and the possible effects on the property and development sector, plus whether or not it was deemed to be a priority for businesses during the ongoing economic and international uncertainty.

Planning

The team is working with key members, especially those involved with the Property Forum, to prepare a submission to what is known colloquially as 'Local Plan 2 Update'. This is Leeds Council's collection of planning papers and evidence-gathering specifically on areas including carbon reduction, flood risk and sustainability. (The consultation deadline is 24 March.)

Manufacturing

The team helped promote this year's Leeds Manufacturing Festival in February. A well-attended event at Leeds City College heard from several local businesses in the manufacturing sector.

York & North Yorkshire

Hospitality

Months of hard work from the P&R team culminated in the successful launch of the new Hospitality Forum in North Yorkshire. An event attended by 60+ representatives from the sector heard how the new group will support the aims and ambitions of businesses still struggling from the pandemic's hangover. Chamber colleagues also attended a Hospitality Expo in Scarborough (a non-Chamber event) to consolidate on the Forum's launch.

Economy

Representations were made at the most recent Business Leaders' Round Table, coordinated by York Council. The latest economic survey results, pressures due to energy bills and the cost-of-living crisis were all flagged up at the February meeting.

Selby

The Chamber joined a discussion with local partners in Selby, known as 'Moving Forward', looking at business support and working more closely with relevant Chamber forums. The meeting was attended by Selby Council, Selby College, Y&NY LEP and construction training specialist PCWY were all present.

Skills

The roll-out of the Chamber's involvement in the Local Skills Improvement Plans continues to progress. Conversations with relevant stakeholders in key areas, such as training providers, colleges and universities have taken place, and a survey to gather information and data is being promoted.
